#### **INVESTMENT OBJECTIVE**

The IFM Income Fund is a multi-managed fund whose primary objective is to provide a higher level return than money market and other income funds by investing in bonds, fixed deposits, other money market instruments, listed debentures, preference shares of an income nature and listed property shares.

## **INVESTMENT PHILOSOPHY**

In order to achieve its objective, the IFM Income Fund will invest in a diversified portfolio of income oriented assets. In addition to participation in portfolios of collective investment schemes, the portfolio's investment universe may consist of equity securities, exchange traded funds, preference shares, debentures, debenture bonds, money market instruments, property shares and property related securities listed on exchanges and assets in liquid form. The IFM Income Fund's equity exposure will never exceed 10% of the portfolio's net asset value.





#### FUND MANAGER COMMENTARY

As the curtain closed on 2023, international markets found themselves riding the wave of a rally in global risk assets. The once looming concerns about imminent recessions and inflation have eased, creating a favourable environment for central banks to consider trimming interest rates. However, amidst the optimism, cautionary flags fly high, with ongoing conflicts in Europe and the Middle East casting shadows over the global economic horizon.

Fixed income markets generally performed well over the last guarter of the year. Positive returns were backed by rising spreads, a declining dollar, and expectations of early central bank cuts. The two most successful sovereign markets during the quarter were in Europe: UK Gilts delivered 8.6% due to a longer tenure in the index, while Italian returns increased to 7.5% due to narrowing spreads compared to German Bunds.

As a result of the above, the FTSE WGBI USD Index produced a strong 4Q gain, up 8.1% (YTD: +5.4%). Locally, the FTSE/JSE All Bond Index (ALBI) also performed well, increasing by +8.0% (YTD:9.6%), with longer dated instruments (7-12+ Yrs) outperforming the shorter dated equivalents (1-3Yrs) for the year.
